Washington State Historical Society [Washington State Heritage Capital Projects Fund Grant](#) Applications for the 2024 – 2026 funding cycle are Due. The purpose of HCPF is to "support capital needs and facilities of 501 c 3 heritage organizations, tribal governments, public development authorities, and local government agencies that interpret and preserve Washington's history and heritage." (WAC 255-02-010) Projects need to have a minimum total budget of \$25,000; request a grant of not more than \$1,000,000; involve property that will be held a minimum of 13 years; and provide a \$2 match for each \$1 of HCPF grant funds.
